## **Victoria's Business Support Fund**

Grants up to \$10,000 are available to support businesses that have been subject to closure or highly impacted by shutdown restrictions. Eligible businesses must employ staff, have a turnover greater than \$75,000, have a payroll of less than \$650,000, hold an ABN and have operations in Victoria.




## Working for Victoria Fund - Further detail to be announced
