Once shortlisted you will be invited to attend an interview with one of our managers and HR team.







# Frequently asked questions

## When are applications open?

We run two cycles of recruitment for the following year. They occur in March and October. Please use this as a guide only and keep an eye on our website and socials when applications are open.

## How do I apply?

Once applications open you can apply through our website or seek.

## What does the recruitment process involve?

The flow of our recruitment follows these steps:

1. Applications open / Apply online.
2. Phone screening discussion with HR.
3. Panel Interview with HR and Partners.
4. Meet and greet with the team in the office.
5. Offer - if successful.

## What qualifications do I need?

Bachelor of Commerce (Accounting), Business (Accounting) or Commerce/ Law with an Accounting major. Students must be able to complete a CA or CPA qualification or to do one bridging course to enable this.

## Do you take international students?

Unfortunately no. You must be an Australia or New Zealand citizen or permanent resident.

## Which service lines do can I apply for?

Business Advisory, Taxation, Audit and Assurance, and Superannuation.

## Do you provide internships or work experience?

Yes, we currently have a 3 week program through CA achiever program during the unibreaks (June/July and November/December).

Work experience placement is also available to support your high school learning objectives.
